



## TRANSFER STATION OPERATOR (Part-Time Position)

Lacombe Regional Waste Services Commission (LRWSC) owns and operates five solid waste facilities within the Lacombe County boundaries. Transfer sites are located at Eckville, Bentley, Spruceville, Alix/Mirror and at Prentiss. Approximately 10,000 tonnes of dry rubble is landfilled annually. Almost the same volume of household/kitchen waste is transported annually to the Class 2 landfill at West Dried Meat Lake.

**Lacombe Regional Waste Services Commission has a part-time permanent opportunity position for a Transfer Station Operator to join our team.**

Lacombe Regional Waste Services Commission (LRWSC) requires a part-time operator based out of the Prentiss Transfer Site working three days, 24 hours per week (Thursday|Friday|Saturday, 10am - 6pm).

The Transfer Station Site Operator is responsible for:

- ◆ assisting, directing and educating customers in proper waste disposal methods;
- ◆ managing the burn pit;
- ◆ changing out the bins;
- ◆ maintaining the cleanliness of the site;
- ◆ conducting visual inspections of loads as needed to prevent disposal of prohibited materials;
- ◆ performing minor preventative maintenance duties, such as greasing and oiling;
- ◆ operating the scales to properly weigh vehicles (on an occasional basis); and,
- ◆ performing other related work as assigned.

We're looking for an individual who has the ability to respectfully communicate with the facility users to assure proper usage and provide assistance as required. The successful candidate is able to work well with fellow co-workers and is able to work in a variety of weather conditions. Being dependable and able to work with minimal supervision is important in this role. Applicants must be able to perform physical labor efficiently. A mechanical aptitude would be an asset. The successful applicant will be able to read, understand and follow the responsibilities and accountabilities as outlined in the Lacombe Regional Waste Services Safety Management System. An acceptable drivers' abstract is required as a condition of hire.
